Confidential informants are necessary and useful to law enforcement but must be treated with caution.

## 2:15 – 3:15 Fertility, Family and a Little Fun

The medical advancements of assisted reproduction have created a myriad of legal complications. Existing laws based on traditional biological families have become quickly antiquated in this legal field. Who are the legal parents of a child born through donor gametes or surrogacy? Does the law recognize donor parent status? The program will discuss rebutting traditional parental assumptions while using marriage presumptions for the rights of parentage. Additionally, embryo disposition has become a recent hot topic in assisted reproduction. Determining the child's parents at birth requires an understanding of who has the right to cryopreserved embryos or gametes in the event of a death or divorce.

Asian intended parents are the fastest growing client base in the speaker's assisted reproduction cases. The dynamics of culture, the law and reproduction will be discussed in this fascinating area of the law.
